It is expected that total number of cancer patients worldwide will reach approximately 28 million, and 16.2 million deaths by 2040. Over 40% of cancer cases are attributed to preventable factors such as smoking bans, healthy eating, physical activity, etc. Basic research and innovative therapies are also changing patients' outcome. The future path to fighting cancer requires international cooperation and the promotion of scientific and technological innovation.

This summit will invite anti-cancer leaders of China and Latin-America to jointly explore basic research, share the latest achievements in clinical practice, and exchange ideas and perspectives on the treatment of cancer patients.

Prof Eduardo L. Cazap

President & Founder-Latin-American & Caribbean Society of Medical Oncology (SLACOM)

Professor Eduardo.L.Cazap is the founder and first president of the Latin American and Caribbean Society of Medical Oncology (SLACOM), the cochair of RINC-SLACOM, as well as the immediate past president of the International Union against Cancer (UICC). Dr. Cazap also is the editor-in-chief of Ecancer, co-editor of Global Health Section and Emeritus Professor-LatinAmerican School of Oncology (ELO). As the ambassador of UICC Summit & Congress, Dr Cazap is internationally known as a regular speaker, chair, and/or moderator at global cancer and health meetings and for organizing major international conferences. Dr. Cazap's main areas of research and interest are global health, cancer control and prevention, breast and cervical cancer, and independent clinical research.



Prof. Daiming Fan President of China Anti-Cancer Association

Professor Daiming Fan is the member of Chinese Academy of Engineering, International member of the USA and French National Academy of Medicine, President of the China Anti-Cancer Association (CACA), President of the Asia Pacific Digestive Week Federation, Member of the Board of Directors of the Union for International Cancer Control (2018-2022), Past Vice President of the Chinese Academy of Engineering, Past President of Asia Pacific Association of Gastroenterology. Prof. Fan specialized in both clinical and basic research into digestive diseases, especially gastrointestinal cancers. He has obtained numerous prestigious awards for his outstanding achievements, including several National Science and Technology Progress Awards. He was the first awardee of the Prize "French National Academy of Medicine-Servier", and received the 2019 Masters of the WGO Award. As editor-inchief he has authored 158 gastroenterology and oncology books, published over 700 peer review articles on international journals and serves as editor for 15 international medical journals.



Prof. Daniel Campos Director, Clinical Research Institute Latin American & Caribbean Society of Medical Oncology SLACOM

Dr. Daniel J. Campos is an esteemed Oncologist and Executive Consultant. He previously led the Oncology Service at San Isidro Central Hospital and held key positions at the prestigious Institute of Oncology Angel H. Roffo, both institutions affiliated with the Buenos Aires University School of Medicine.

With a rich academic background, Dr. Campos is a Professor of Pharmacology, Public Health, and Clinical Medicine at UNBA. He also served as a hired Investigator for the Cooperative Program of Clinical Research PAHO-OMS at the Lombardi Comprehensive Cancer Center, Georgetown University Medical Center in Washington DC.

Dr. Campos is a Principal Investigator in international clinical trials focusing on various areas of solid tumor oncology. His expertise in oncology research in Latin America has earned him recognition from media outlets like The Washington Post. Currently, he serves as the Director of the Clinical Research Institute of SLACOM. Additionally, Dr. Campos played vital roles in the International Affairs Committee and the International Clinical Trials Workshop ICT Working Group at ASCO. Notably, Dr. Campos serves as a project leader in the RINC SLACOM Advisory Committee, further cementing his position as a driving force in oncology research.
